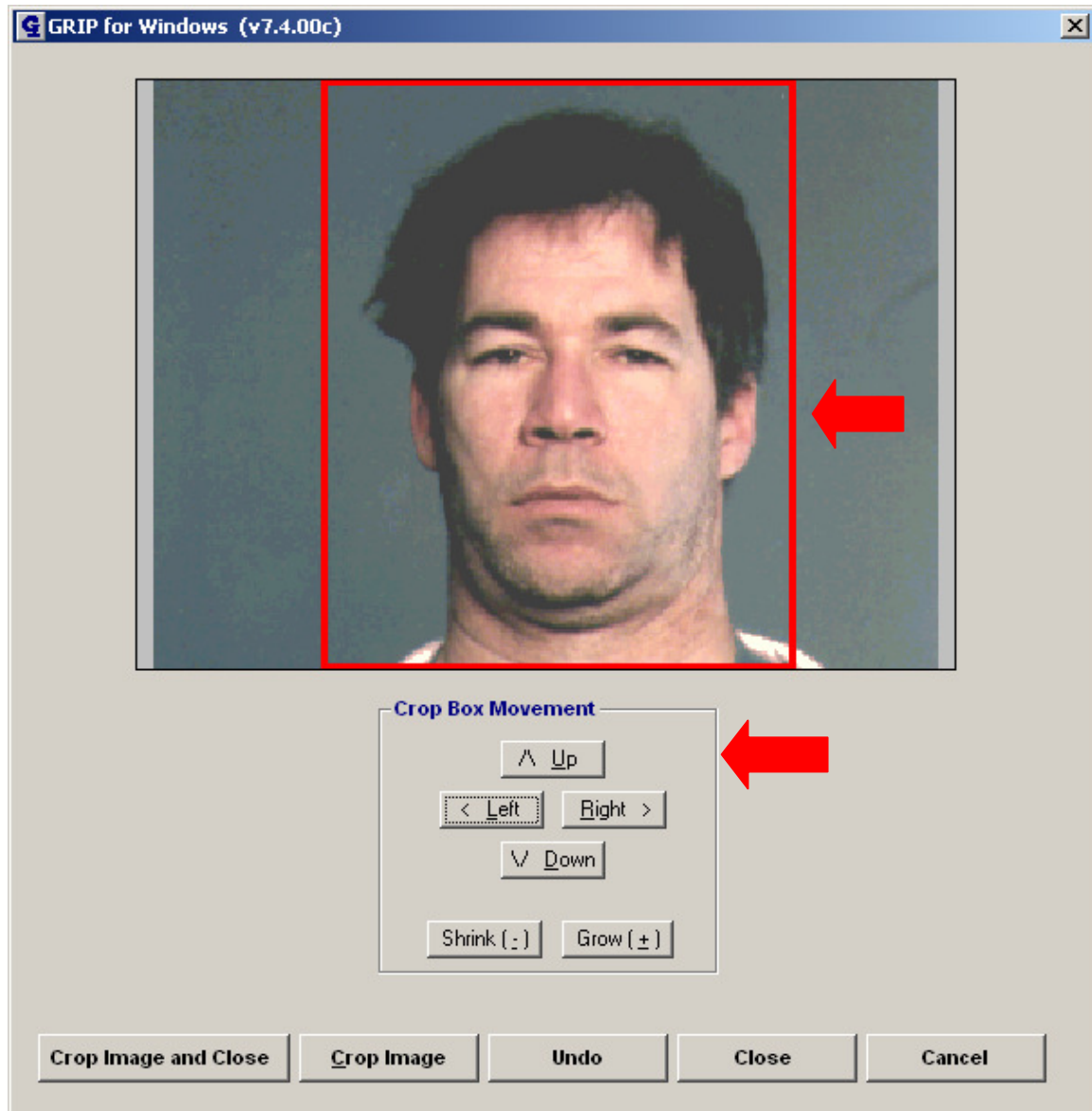
Default Booking Officer to Logged in User: A Yes/No flag indicating if the booking officer will default to the employee associated with the current user. (The association is defined using the **User to Employee Association** window.)

Show Subject Related Tabpages for Defendants: A Yes/No flag indicating if the Subject Name and Demographics tabs are visible on the Suspect/Defendant window.

Image Cropping

The ability to crop images to the Width: Height aspect ratio of 1:1.25.

This functionality is based on the Best Practice Recommendation for the Capture of Mugshots, Version 2.0, September 23, 1997.



The image crop box allows users to remove unwanted portions of an image and resize it to a width/height aspect ratio of 1 : 1.25. The crop box can be shrunk and enlarged as well as repositioned to allow for the best display of the image.
